Minutes: October 2015

The October 29th meeting was held at the Mount Pleasant Community Center with 21 members present. A moment of silence was held for deceased members.

Minutes: The minutes of the September meeting were read by Marilyn. Moved by Marilyn, seconded by Curtis, "The September minutes are approved as presented". Carried.

Treasurer's Report: Villa presented her financial report including trust fund information. Moved by Marilyn, seconded by Eugene, "The Treasurer's report is approved as presented." Carried.

Old Business:

1. Fall Rally: Lloyd thanked everyone for their support at the Fall Colour Rally.
2. Little Pokiok Bridge: This bridge will be repaired in the spring.
3. Surveillance Signs: The signs have not been ordered and Allison will report at the next meeting.
4. Trail Signage: The signs have arrived and the posts will be delivered shortly. A discussion was held regarding the requirements and concerns the Club has in ensuring proper placement of the signs. A summary of the discussion on these signs from the recent Regional meeting was presented. For example, the sign posts must be painted blue, only two signs per post, distance requirements to turns, erecting and removal, height above ground, inspection, etc. was presented.
5. Cards: The Thinking of You card template was approved by the Exec. members and Bob will check with the printer. (Followup: Bob checked the next day and the cards are being printed and will be available in a few days)

New Business

1. Trail Pass 2016: Lloyd summarized a discussion on this topic from the Regional meeting. Passes will be forwarded to our Club in advance of the October 1st requirement.

3. DNR: Allison suggested a representative from our local DNR office be invited to our next meeting

5. NBATVF Directors Meeting: Our Club will host a trail run in June 2016 during the Directors meeting. It was suggested this run be held in conjunction with our Spring Rally in June. More information to follow on this meeting and run.
6. Club Trailer: The trailer is now in storage for the winter.
7. Regional Meeting: Allison and Lloyd summarized the topic discussion from the recent Regional meeting. Topics included a report on the trust fund, 2016 jamboree, Provincial trail, Trak-Map, trail numbers, trail permits, etc.
8. Election of Officers for 2016: The Officers for 2016 are: President Curtis Crain; Vice-President Allison Kent; Secretary Marilyn Everett; Treasurer Villa MacKenzie.
