The February meeting was held at the Mount Pleasant Community Center with 27 members present.

**Minutes:** The minutes of our January meeting were read. Moved by Villa, seconded by Kevin, "The minutes be approved as presented." Carried

### **Business Arising:**

**1. Trail Map:** There are few copies of the trail maps. Reference was made that 83 people have downloaded the map from the website. A quote was received from Kwik Kopy for 500 maps for \$400 + HST. Moved by Doug, seconded by Villa, "Skedaddle Ridge have printed 500 Trail maps." Carried. Bob indicated he was only aware of three corrections to be made on the map, would rectify and arrange for printing.

**2. Signs:** A letter was received by the President indicating the necessity to present to the NBATVF the number and design of signs required to complete signage of our trails. Pres. Allison, based on the kilometers remaining, discussed this topic and the Club determined how many would be required. It was noted the order and placement will be in accordance with the NBATVF sign manual.

**3. Storage Trailers:** The Club will move the trailers to another location in the spring as the land the trailers are currently situated is for sale.

**4. Trail Permit:** The Club briefly discussed the Trail Permit Options presented at the January meeting. Moved by Stirling, seconded by Norm, "Skedaddle Ridge supports Option C, Option 2." Carried

**Treasurer's Report:** Villa presented the Treasurer's report. Moved by Villa, seconded by Curtis, "The Treasurer's report be approved as presented." Carried

### **New Business:**

**1. Events:** The Club discussed the events and dates for the 2015 year. They are as follows: June 13<sup>th</sup> -- Spring Rally; July 11<sup>th</sup> -- Fun Run; Aug. 8<sup>th</sup> -- Pres. **2. Geo-Cache:** Following discussion, the members decided to place additional geo-cache boxes on the trail network and post the waypoint co-ordinates on both the Skedaddle Ridge website and the Provincial geo-cache website.

**3. Coffee Makers:** Moved by Raymond, seconded by Eugene, "Skedaddle Ridge purchase two coffee makers for the Mount Pleasant Community Center." Carried

**4. Annual General Meeting:** The NBATVF Annual meeting will be held in the Miramichi April 11-13, 2015. The Club nominated Pres. Allison and Kevin to attend. Caleb agreed to be the alternate in the event a person was not able to attend.
